

**Order of the Minister of Agriculture and Maritime Fisheries No. 1063-15 of 10 Jounada II 1436
(31 March 31, 2015) setting up the form and content of the register of regular health visits
established by the operator of establishments or companies in the sector food and animal feed
sector other than retail sales and collective catering.**

THE MINISTER OF AGRICULTURE AND MARITIME FISHERIES,

Having regard to Law No 25-08 setting up the National Food Safety Office, promulgated by Dahir No 1-09-20 of 22 Safar 1430 (18 February 2009), in particular its article 2;

Having regard to Decree No 2-10-473 of 7 Shawal 1432 (6 September 2011) taken for the application of certain provisions of Law No 28-07 relating to the health safety of food products, in particular its article 24,

ORDERS:

ARTICLE 1. The register of regular health visits provided for by Article 24 of the said Decree No 2-10-473, set up by the operators of establishments or companies in the food sector and the animal feed sector approved or authorized in terms of health, other than retail sales and collective catering shall comply with the model annexed to this Order.

This A4 format register shall include a cover page and 100 pages with serial numbers.

Each page of the register shall contain the following information:

- The visit date;
- The stages of the production chain controlled;
- The non-conformities noted;
- The recommendations;
- The corrective measures proposed by the establishment or company;
- The deadlines for carrying out corrective measures;
- The reference of the visit report;
- The signature of the operator of the establishment or business;
- The names, qualifications and signatures of the people who carried out visit.

ARTICLE 2 - Any visit to the establishment or company shall be mentioned in the register together with its date, name and signature of the operator and the people who carried the visit, and the information referred to in article 1 above in the corresponding sections.

The register shall always remain accessible to agents authorized to carry out regular health visits.

ART. 3. - This Order Shall be published in the Official Gazette.
