

**Joint order of the Minister of Agriculture and Maritime Fisheries, the Minister of the Interior and the Minister of Health No. 2768-12 of 12 Ramadan 1433 (1 August 2012) establishing the Activity Code and the Prefecture/Province Code to be included in the numbering of Health-related Authorizations and Approvals.**

In view of Decree No. 2-10-473 of 7 Shawal 1432 (6 September 2011) taken for the application of certain provisions of Law No 28-07 relating to the health safety of food products and in particular its article 13;

Having regard to Decree No. 2-09-319 of 17 Jounada II 1430 (11 June 2009) amending and supplementing Dahir No. 1-59-351 of 1 Jounada II 1379 (2 December 1959) relating to the administrative division of the Kingdom,

**ORDER:**

**ARTICLE 1.** - The activity code and the code of the prefecture or province where the establishment or company is located, provided for in article 13 of Decree No. 2-10-473 referred to above, which must both appear in the numbering of health-related authorizations and approvals of establishments and companies operating in the food sector and the animal feed sector, shall be set out respectively in Annexes I and II of this order.

**ART. 2.** - This joint order shall be published in the Official Gazette.
