THE MINISTER OF AGRICULTURE AND MARITIME FISHERIES,

In view of Decree No. 2-15-219 of 5 Ramadan 1436 (June 22, 2015) taken for the application of article 21 of Law No 28-07 on health safety of food products, in particular its article 2,

ORDERS:

Article 1. The model of the professional card, as attached to this order, is hereby established in accordance with Article 2 of Decree No. 2-15-219 referred to above. This card shall be issued by the Director General of the National Office for Food Safety (ONSSA) and must be held and visibly worn by the agents referred to in Article 1 of the same decree while performing their duties.

Article 2. - This order shall be published in the Official Gazette.
