

Joint Order of the Minister of Agriculture and Maritime Fisheries and the Minister of Economy and Finance No. 4486-14 of 19 Safar 1436 (12 December 2014) fixing the remuneration payable by the State to private-sector veterinarians with health mandate and the terms of its allocation.

**THE MINISTER OF AGRICULTURE AND MARITIME FISHERIES,

Having regard to Law No. 25-08 establishing the National Office for Food Safety, promulgated by Dahir No. 1-09-20 of 22 Safar 1430 (18 February 2009), particularly Article 2 thereof;

In view of Decree No. 2-82-541 of 29 Jumada I 1403 (15 March 1983) issued for the implementation of Law No. 21-80 on the private practice of veterinary medicine, surgery and pharmacy, particularly its Articles 6 and 8 thereof,

ORDER:

Article 1 - (amended by Joint Order No. 376-18 of 30 January 2018 – OG No. 6652 of 1 March 2018, p. 549; amended and supplemented by Joint Order No. 2882-24 of 26 November 2024 – OG No. 7384 of 6 March 2025, p. 406) - In accordance with Article 8 of Decree No. 2-82-541 mentioned above, the remuneration payable by the State to private-sector veterinarians with a health mandate, tasked to perform the operations listed below, are fixed as follows:

1° Vaccination operations of animals against diseases:

	Amount in MAD/head (including tax)
- sheep, goats	5.60
- cattle	11.20
- equines	8.00
- camels	10.00
- canines, felines	10.00

2° **Animal identification operations:**

a) For the sole identification:

	Amount in MAD/head (including tax)

b) For identification carried in conjunction with a vaccination operation referred to in 1° above, the following amounts shall be applied in addition to the fees for the vaccination:

3° Samples collected from animals for laboratory analysis:

Article 2 - (amended by Joint Order No. 376-18 of 30 January 2018 – OG No. 6652 of 1 March 2018, p. 549) The operations referred to in Article 1, entrusted to private-sector veterinarians with a health mandate, shall be assigned to each veterinarian by decision of the Director General of the National Office for Food Safety (ONSSA). Each decision shall specify the operation or operations entrusted to the veterinarian, the procedures for their execution, and the area of intervention assigned to them.

Article 3 - In accordance with Article 6 of Decree No. 2-82-541 referred to above, private-sector veterinarians with a health mandate shall be required to carry out the operations assigned to them under Article 2 within the zone(s) allocated to them.

Article 4 - The file for the payment of fees to private-sector veterinarians holding a health mandate shall be submitted by the applicant, against receipt, to the ONSSA veterinary service of the area in which the operations were carried out.

This file shall include:

- A summary sheet, dated and signed by the applicant, of the operations carried out, prepared according to the form issued for this purpose by the veterinary service of the aforementioned ONSSA;
- The end-of-operations report, provided for in Article 7 of Decree No. 2-82-541 referred to above, dated and signed by the applicant, prepared according to the form issued for this purpose by the veterinary service of the ONSSA, in four copies;
- A copy of the order granting the health mandate to the applicant;
- A copy of the applicant's national identity card;
- A copy of the decision referred to in Article 2 above.

Based on the above-mentioned documents, the Director General of ONSSA, or a person delegated by him for this purpose, shall issue a decision on the payment of fees.

Article 5 – Expenditures in relation to the remuneration of veterinarians provided for in Article 1 above shall be charged to the ONSSA budget.

Article 6 - Joint Order of the Minister of Agriculture and Agrarian Reform and the Minister of Finance No. 1610-92 of 28 Rebia II 1413 (26 October 1992), fixing the rates of fees payable by the State to private-sector veterinarians with a health mandate, as amended, is hereby repealed.

Article 7 - This joint order shall be published in the Official Gazette.
